

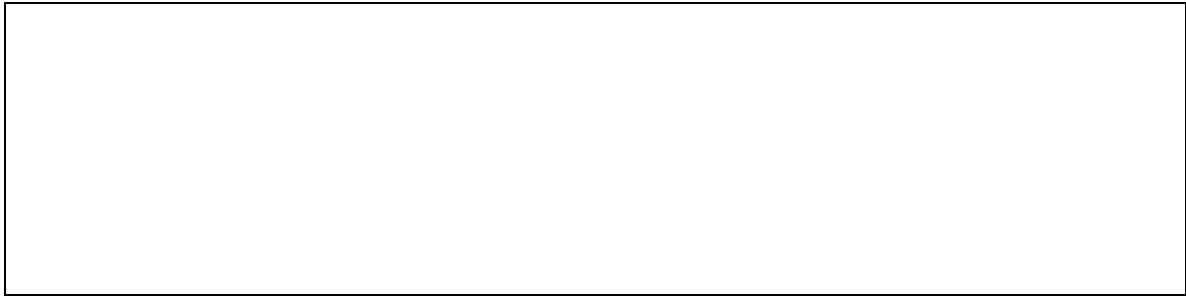

Written acknowledgement from the applicant’s supervisor is also needed. This should clearly state that the applicant will be allowed to attend TLA if awarded the stipend.
